cities and the County. Specifically, Vignone and Coile are coordinating advocacy for a Farmworker Housing Study to assess the size and makeup of Ventura County's farmworker population, their housing

needs, and barriers to the construction of farmworker housing. Another key role is to support Housing

Trust Fund Ventura County with the creation of a countywide dedicated source of funding for affordable housing.
